# Honoring the Past & Building for the Future

*60<sup>th</sup> Anniversary Event to Raise Funds for Children's Center Capital Campaign* 



United Cerebral Palsy of Northeastern Pennsylvania will commemorate 60 years of service to the community with an Anniversary Dinner to be held at the Radisson Hotel at Lackawanna Station on Wednesday, August 28<sup>th</sup>.

The dinner program will honor State Senator John Blake, Andy Gavin's Pub & Eatery and the

NEPA Fit Club. Senator Blake, who is a former Board member of UCP of NEPA, has been a strong advocate for people with disabilities and the organizations which provide them services for many years. Don Surace, owner of Andy Gavin's, conducts the Green Ridge Mile, a 5K race which is held in the Green Ridge section of Scranton every year over Thanksgiving weekend, and has donated proceeds to the agency for many years. Mike Marcinek, owner of the NEPA Fit Club, along with his family and friends, each vear conducts FitStock: For a Cause, and for the past several years has chosen UCP as the cause. The anniversary event will begin with a cocktail hour at 5:00pm. The program following dinner will include a retrospect of the agency along with the award presentations. A special commemorative program booklet is also being prepared, in which we are selling advertising space to local businesses and our supporters. Proceeds from both the dinner and the program book

dinner and the program book are being designated for the Capital Campaign to replace our Clarks Summit Children's Center. As you may be aware, the Center has been the site of repeated flooding over the years, causing costly damage to the building and equipment, not to mention interruptions to the services housed there. UCP's Lekotek and Compuplay programs are housed in the facility, along with the administrative facilities for our Early Intervention services. A private day care center also operates in the building. Currently, the first floor of the building is set only about 18 inches above the water table which means that any

substantial rainfall can cause problems with more severe storms having resulted in the temporary closing of programs. Our plan is to erect a new building in the footprint of the existing structure, but raised well above the water table to avoid the flooding issue in the future. #### <u>PIAT</u>

Pennsylvania's Initiative on Assistive Technology leads the Commonwealth's efforts to implement the provisions of the federal Assistive Technology Act of 1998, as amended. As a sub-contractor, the Assistive Technology Resource Center at UCP of NEPA has provided services in six counties of northeastern Pennsvlvania. Our activities include: Device Demonstrations (a hands-on opportunity to learn more about different AT devices so individuals can make an informed choice about what will work best for them); Device Loans (Pennsylvanians of any age and ability can borrow AT devices, at no cost, to try at work, school, home or in their neighborhoods; Acquisition, Training, Technical Assistance and Public Awareness Activities. Please contact the ATRC if vou would like more information on any of these services.

#### **ICanConnect**

The ATRC at UCP of NEPA recently became part of the outreach activities for iCanConnect, the National Deaf-Blind Equipment Distribution Program (NDBEDP). The ATRC has begun conducting outreach events to increase awareness of this program. The NDBEDP will ensure that low-income individuals who have combined hearing and vision loss can access telephone, advanced communications and information services. This program was mandated by the Twenty-First Century Communications and Video Accessibility Act of 2010 (CVAA), which authorizes the Federal Communications Commission (FCC) to provide funding for local programs to distribute equipment to low income individuals who are deaf-blind or have hearing loss and vision loss.



#### <u>TDDP</u>

The Telecommunication Device Distribution Program provides specialized equipment free of charge, to eligible Pennsylvanians who have disabilities which impede their independent access to telephone services. This includes people who are deaf, hard of hearing, speech impaired, blind or have visual problems, or have physical or intellectual disabilities. Created through PA Act 34-1995, the TDDP is implemented by PIAT, Pennsylvania's Initiative on Assistive Technology, a program of the Institute on Disabilities at Temple University, in coniunction with the PA Office of Vocational Rehabilitation (OVR) and the PA Public Utility Commission (PUC). Pictured at left is the Fortissimo, an amplified speaker phone which can be used with a wireless switch/ pendant for people who have difficulty dialing. Contact the ATRC at UCP of NEPA for a demonstration of this or any of the other phones offered through the TDDP.
