OPPORTUNITIES FOR CHANGE & PROGRESS IN THE 110TH CONGRESS

The 110th United States Congress convened its first session on January 4, 2007 with the Democrats in control of both the Senate and the House of Representatives for the first time in 12 years. Pennsylvania's General Assembly convened in early January as well, also with many new members.

Both chambers of the legislatures at both the federal and the state levels announced ambitious agendas. Part of the work of organizations like United Cerebral Palsy is to make sure the needs of persons with disabilities are included in those agendas. On the national level, UCP has partnered with several leading disability advocacy groups to form the Disability Policy Collaboration (DPC) which has itself embarked on an ambitious set of goals to pursue in the 110th Congress.

Many of the priorities the DPC has identified are related to the federal budget. Ensuring adequate funding for disability related services is always a challenge, and more so in the current fiscal atmosphere. In addition to the current budget deficit and continuing increases in defense spending, at the beginning of this session, Congress enacted the PAYGO (Pay As You Go) provision which requires that any new spending on entitlements such as Medicaid be offset by spending cuts in other areas or by tax increases.

The overall goals of UCP and its partners in the DPC are; protection of the rights of people with disabilities, expansion of community-based service systems, and protection and expansion of benefits for their constituents. Among the specific objectives:

- Medicaid advocates are looking to Congress to oversee waivers that have been approved in several states that alter basic Medicaid provisions. Also they will work to make amendments to programs created by the Deficit Reduction Act of 2005 such as the home and community based services option to make them work better for persons with disabilities.
- Direct Support Professionals bill would provide funds to enable states to increase the wages paid to direct care workers in community based settings to make them comparable to those paid to workers in government-run Medicaid programs.
- Housing efforts to prevent or minimize expected cuts to the Section 811 Supportive Housing for People with Disabilities Program and the Section 8 Housing Choice Voucher Program.
- Education the No Child Left Behind Act is scheduled for reauthorization this year. Disability groups strongly supported the principles in the NCLB act, especially the notion that all children, including those with disabilities, be assessed to determine their academic progress.

- ADA Restoration a number of court decisions have in effect denied the law's protections to people with disabilities. Congress is expected to clarity the definition of disability in line with the original intent of the law.
- Assistive Technology since increased funding seems unlikely, emphasis will be on attempting to bring every state program to the minimum allotment level defined in the 2004 reauthorization, and restore funding lost in recent years.
- Civil Rights several pieces of Voting Reform legislation are under consideration this year and the DPC partners intend to ensure that whatever reforms are implemented, voting systems and processes are fully accessible to people with disabilities.
- Health Care advocates hope to expand funding of the State Children's Health Insurance Program (SCHIP), but any increase must comply with the PAYGO provision.
- Long Term Community
 Supports the Community
 Living Assistance Services and
 Supports Act (CLASS Act)
 would create a national, premium-based, long-term supports
 insurance program for Medicaid
 eligible people. The bill could
 take pressure off the Medicaid
 system while providing more
 individual choice in long-term
 supports.

New Assistive Technology Service Improves Telephone Access for People with Disabilities

Pennsylvania's Telecommunication Device Distribution Program (TDDP) is the newest service of PIAT, Pennsylvania's Initiative on Assistive Technology and the Assistive Technology Resource Center (ATRC) at United Cerebral Palsy.



The TDDP provides specialized equipment, without charge, to eligible Pennsylvanians who have disabilities that impair their ability to access telephone services. Devices available thru the program include TTY (text telephone), TTY with large visual or Braille displays, amplifiers, voice activated dialers, and telephones with large buttons. The program is coordinated by PIAT in cooperation with the PA Office of Vocational Rehabilitation and the PA Public Utilities Commission.

State & Local Efforts Focus on Funding

UCP of Northeastern Pennsylvania recently participated in a Legislative Breakfast sponsored by the Lackawanna & Susquehanna Counties Mental Health/Mental Retardation Providers Council.

Members of the Council sought to inform legislators, many of whom are newly elected, of the work of their respective agencies.

Many pieces of legislation have important implications for people with disabilities and the programs that serve them and the Council wants to make sure that legislators know how the issues affect their constituents who have disabilities.

The Governor's 2007-08 budget proposes a 3% cost of living adjustment for agencies to offset rising costs and maintain competitive wages and the Council urged the legislators to keep that and other provisions intact.
