### How Can We Help You?

As is the case for many offices, when you call UCP of Northeastern PA. our standard greeting includes "can I help you?" UCP provides direct help to people with disabilities and their families. Our services for children include the early intervention program, in which agency staff provide therapy and educational activities designed to build upon the natural learning that occurs during the first few years of a child's life. The Lekotek and Compuplay programs utilize specially adapted toys and computer games and activities, respectively, to enhance the child's development. The center-based Adult Day program provides educational activities, skills training, and

vocational and recreational opportunities designed to help adults with developmental disabilities attain their goals. Work Connections, our supported employment program, helps them obtain and succeed at employment in the community workforce. Residential Services consist of seven Community Living Arrangements which provide full-time support for several adults living in each house, and the Supported Independent Living program which provides part-time assistance for those living in their own apartments.

The Home Services program provides information, advocacy and referral services to children and adults with disabilities as well as their

families to help them address various issues and problems. The Assistive Technology Resource Center provides information, referral and assistance for children and adults with disabilities who need assistive devices in order to attend school, work, participate in the community or live independently. If any of our services can help you or someone you know, please don't hesitate to contact us.

There are other ways that this affiliate and our national office try to be of assistance to those with disabilities. In addition to information about our own services, our website at www.ucpnepa.com has a resource page with links to other organizations and government services that may help individuals and families deal with problems, find appropriate services, or advocate for themselves. Especially in the realm of advocacy, our national office's website located at www.ucp.org provides assistance for individuals with disabilities and those who work with them, as well as ways for the community to get involved in the discussion. initiatives that offer help are DontBlockMyVote.org and MyChildWithoutLimits.org. Launched in 2004 to register new voters and raise awareness about polling place accessibility, Don't Block My Vote has expanded its role to include getting issues of importance to those with disabilities attention during political campaigns. The site includes an online voter registration tool, links to file complaints about accessibility and eligibility problems, and a blog to share experiences, ideas and information. My Child Without Limits is both a source of information and an online community forum for parents of children with special needs. The site includes a developmental milestones chart, information on various disabilities as well as treatments and therapies for specific conditions, and a national resource locator to help parents find service providers, community organizations and government agencies in their geographic area. The community platform on the site enables parents to share ideas and experiences, ask questions and offer support to others as peers. The national UCP has joined forces with the Arc of the United States to form the Disability Policy Collaboration (DPC). The DPC works with our national leaders on issues including the ADA, education, housing, and Social Security, making sure the needs and interests of persons with disabilities are part of the equation.

### New Ways to Communicate!

Pennsylvania's Telecommunication Device Distribution Program (TDDP) provides specialized equipment, free, to eligible Pennsylvanians who have disabilities which impede independent access to telephone services. This includes people who are deaf, hard of hearing, speech impaired, blind or have visual problems, or have physical or intellectual disabilities.



Recently added to the TDDP inventory is the Clarity XL-50, a phone that amplifies up to 60 dB and has an adjustable ringer up to 95dB. Tone can be adjusted as needed, with four settings. Features: II memory buttons, a bright ring flasher. It is hearing aid compatible. Optional bed shaker and wireless lamp flasher are also available with this phone.

The Krown vTouch Braille TTY enables individuals who are Deaf/Blind to communicate on the phone. It has a 20 cell 8 dot refreshable Braille display. Users can choose between using the full QWERTY keyboard or using the home row keys and spacebar as a Braille keyboard. This may benefit individuals who are deaf and blind.



The DynaWrite is a keyboard-based text-to-speech communication device with synthesized speech. It has a variety of selection methods and scanning configurations. The PhoneIT accessory is required to connect the DynaWrite to a telephone line. This equipment may benefit individuals who may not be able to speak clearly using their voice or who have lost their voice.

The Assistive Technology Resource Center at UCP is the point of contact for the TDDP in Lackawanna, Susquehanna, Wayne, Wyoming, Pike and Bradford counties. The ATRC at UCP can provide information and assistance in applying for services and has some of the equipment on the TDDP list available for demonstration.
