November is Assistive Technology Awareness Month

Since November is Assistive Technology Awareness Month, we thought we'd make you aware of some services the Assistive Technology Resource Center at UCP provides. From determining what type of equipment might work best to assistance with financing options, the ATRC at UCP works to help individuals with all types of disabilities become or remain active, productive members of their communities.

Linda Mesavage, our Assistive Technology Practitioner (ATP), can evaluate the person to determine what type of device is needed, based on his or her particular limitations as well as their abilities, and taking into consideration where and how the device will be used. She can also help the individual set up and learn how to use the device. Sometimes a number of devices may work for a person. This is where the ability to try out a device before purchasing comes in handy. As an ATRC, our program is the contact for PA's Assistive Technology Lending Library, thru which people can borrow devices for a short time so they can find the one that works best.

Once a device is decided upon, there are a number of programs our ATP can help the person

access in order to obtain it. The Reutilized and Exchanged Equipment Partnership (REEP) consists of several services that may be a source for previously owned devices. The REEP Classifieds is an online listing of devices that people are looking to sell or donate. Into New Hands and Liberty Wheels are among the programs that refurbish equipment for reuse. For those with disabilities that hamper their ability to use the telephone, Pennsylvania's Telecommunication Device Distribution Program (TDDP) provides specialized equipment free of charge.

If an individual needs to purchase a device, PA's Assistive Technology Foundation provides low and no-interest loans for people of all ages, income levels and disabilities. Our ATP can also help individuals investigate other financial assistance such as health insurance, public programs, and non-governmental sources.

The Lending Library, the REEP programs and the TDDP are all supported by PIAT, Pennsylvania's Initiative on Assistive Technology, a statewide program created to ensure that all Pennsylvanians with disabilities have access to assistive technology devices and services.

TDDP

The list of approved equipment that this program provides free to eligible Pennsylvanians who have disabilities which impede them from having independent access to telephone services has changed only slightly this year. There is a new exceptions policy which creates a process to secure an appropriate device if it can be documented that none of the approved equipment will meet the needs of an eligible individual,

A Few Updates...

Wyoming County Services
The ATRC at UCP of NEPA
recently received an expansion
grant from the United Way of
Wyoming County.
The grant, awarded in June, has
allowed for additional services in
the county, as well as for the
purchase of equipment for
demonstrations and for the
county's AT Lending Library.
The grant will expire at the end
of this year.

AT Lending Library
Budget cuts have made its services less accessible. To reduce costs some equipment is now housed at the regional ATRC's, each of which covers a large area. People who must now pick up and return equipment may face a long drive. The reduced funding is also causing repair and replacement problems resulting in longer wait lists for equipment. The result is that less people are getting the equipment they need.
