#### Assistive Technology - From the Classroom to the Workplace & Beyond

Often, when a student needs assistive technology in the school, at home, or both, it is likely that it will be needed in the future; in a college setting, the workplace or in the community. As part of the planning process for the transition from school to adulthood, assistive technology needs in all settings and circumstances should be considered.

By Pennsylvania law, the student's Individualized Education Plan (IEP) team, which generally community activities? Listing any AT devices low to high tech, specialized or "off the shelf" that the student currently uses in school, at home and in the community is the first step. For each device on the list, the family and the team should think about the following: Who owns the device? Will the device be needed after graduation - for postsecondary education, employment, independent living, or to participate in

As one of eight Assistive Technology Resource Centers (ATRC) across the state established by Pennsylvania's Initiative on Assistive Technology (PIAT), the ATRC at UCP of NEPA provides a number of services in Bradford, Lackawanna, Susquehanna, Pike, Wavne and Wyoming Counties that can be utilized by students and their families as well as any Pennsylvanian.


#### **Golf Tournament Raises Funds for Early Intervention**

The ATRC can help individuals access programs such as: the PA Assistive Technology Lending Library, through which they can borrow devices to find what works best for them; the Telecommunications Device Distribution program, which provides specialized equipment to those whose disability impedes their access to telephone services; PA's Assistive Technology Foundation, which provides low and nointerest loans for the purchase of devices; and several PIAT supported programs that may be a source for "previously-owned" devices which are generally less expensive than new.


