Community Options provides transportation and other assistance for participants to engage in activities of their choosing. Individuals and small groups have enjoyed a variety of recreational and social outings such as movies, shopping and sporting events. Now, the consumers would like to get more involved in activities that benefit the community. Consumers and staff have over the past several years made and donated or taken up collections of items for local charities including the Griffin Pond Animal Shelter, the Gino Merli Veteran's Center and Shaeffer's Retreat. Occasionally, as part of Community Options activities, they delivered the collected items and got a firsthand look at the work these groups do. The program is currently looking for area organizations that are in need especially of onsite volunteers. On site activities are specifically being targeted to give the program participants the opportunity to interact with people other than caregivers, program staff and each other. It is also hoped that some activities can be arranged that might enhance work skills. UCP staff will work with community groups to find the right people to fit their needs and to work out scheduling. Through the variety of program activities in which they have participated, individual abilities, interests and talents have emerged. The individuals involved in the program have varying levels of ability but share the desire to give back to their community - to in effect transition from a consumer to a contributor.

# UPDATES ON ASSISTIVE TECHNOLOGY

#### AT LENDING LIBRARY

As with most social service programs, the services provided by the Assistive Technology Resource Center at UCP have been adversely affected by the current economic climate even as the need for those services increases. Assistive technology programs also face level funding or possible cuts as the state and federal budget processes continue.



Consumers who need to borrow equipment from the Assistive Technology Lending Library system must now pick up and return some devices to their regional ATRC, and there are often longer waiting periods to borrow equipment. Funding problems are also leading to delays in repairing and replacing equipment in the library's inventory.

#### PIAT

The number of trainings for individuals with disabilities has increased and consumers are showing a real interest in using iPad and iPod apps. Many of the new mainstream technologies show promise in being of assistance to those with disabilities. Funding will likely end up being an issue here as well.

#### TDDP




